

How to access this discount:

- 1. Show your City of Whitehorse ID when purchasing a transit pass at City Hall.
- 2. Access the discount through the new mobile APP Token Transit

To access this discount with the mobile APP, employees must contact BusTokens@whitehorse.ca, where they will receive a 6-digit code.

Once you have received the 6-Digit Code:

Navigate to this *LINK* to apply the code – Click *SUBMIT*

You will receive a confirmation **TEXT** with a link in the message – Click the **LINK**

The app will open (or prompt you to download the app)

Complete the order by selecting the **BUY NOW** option.

To have access to this discount, one must:

- Be an active City employee



Canada Games Centre Discount

EMPLOYEE PURCHASE GUIDELINES for Canada Games Centre (CGC) Passes



Eligibility

The City of Whitehorse discount on CGC memberships is intended only for the employee, spouse, and children or dependents under the age of 21 and living at home. Eligibility for children extends to age 25 if they are enrolled in college or university as full-time students. Eligibility is based on active employee status, confirmed by City of Whitehorse Employee ID, or by Human Resources, unless otherwise stated.

Employees are required to show current CITY ID at time of purchase. You may be turned away if unable to present valid City ID.

The benefit applies to 30 Day Passes, 6 month and 1 Year memberships, as defined below.

Casual & Temporary Status - 30 Day Pass, 6 Month Membership

Casual and temporary employees with current City ID are eligible only while they are actively employed

Term & Permanent Status - 30 Day Pass, 6 Month or 1 Year Membership

- Employees hired as term, permanent full-time, or permanent part-time
- Includes Mayor and City Councillors during term of office and Volunteer Firefighters
- City of Whitehorse Retirees, in accordance with the Retirement Admin Directive, as verified by Human Resources

Ineligible

- An Employee's parents or siblings, even if living in the same home
- Contract workers and recreation instructors

Purchase Procedure

- Purchase the pass in person at the Canada Games Centre Reception Desk.
- 2. Employees must present their City ID at time of purchase. You may be turned away if unable to present City ID.
- 3. Indicate the type of membership you would like to purchase.
- 4. Provide payment at time of purchase or request payment plan.

Note: An employee can purchase a membership for their family members without including themselves on the pass.

Relevant Collective Agreements & Bylaws

Y022 - The Employer agrees to pay fifty percent (50%) of the cost for an employee to purchase a pass (single or family) membership fee for the Canada Games Centre.

Y023 - The Employer agrees to pay fifty percent (50%) of the cost for an employee to purchase a pass (single or family) membership fee for the Canada Games Centre.

IAFF - All employees will be provided a 50% discount to adult or family passes for access to the Canada Games Centre.

Management & Management Staff Bylaw - The Employer shall reimburse fifty percent (50%) of the cost for an Employee to purchase a membership pass (single or family) for the Canada Games Centre.

Marks 10% Discount Cards

Available for all employees and can be picked up at the Human Resources office at the Whitehorse operations building.
