#### **GENERAL INFORMATION**

#### **Filing the Nomination Paper**

Nominations open on September 10, 2024 and close at 12:00 noon on nomination day, which is September 26, 2024. <u>Under no circumstances</u> will late Nomination Papers be accepted.

On nomination day (September 26), Nomination Papers will be accepted by the Returning Officer between the hours of 10:00 a.m. and 12:00 noon in Council Chambers at City Hall, 2121 Second Avenue. Candidates who wish to file their nomination papers in advance of nomination day may do so by arranging an appointment with the Returning Officer. Early filing is encouraged.

Nomination papers may be delivered electronically, or delivered by a person other than the candidate, to the Returning Officer, as long as the declarations have been administered by a designated municipal officer or a notary public.

#### **Signing the Nomination Paper**

Several sections of the Nomination Paper require your signature. Signatures must be made in the presence of the Returning Officer, a designated municipal officer or a notary public.

#### **Nominating Electors**

Prospective candidates must be nominated by at least 10 electors. It is recommended that you collect in excess of 10 nominations to ensure that at least 10 of these are being made by electors who are qualified to vote in the election.

#### **Confirmed Candidates**

Once your Nomination Paper is approved by the Returning Officer, you are a confirmed candidate. As a confirmed candidate, your information will be included on the City of Whitehorse website and provided to electors.

<u>Note:</u> Although your name as a candidate has been publicized, campaign signage may not be erected prior to the close of nominations on September 26. Refer to *Information for Prospective Candidates* for rules pertaining to signage.

#### **Candidate Name on Ballots**

Following the close of nominations at 12:00 noon on September 26, the Returning Officer will draw lots to determine the ballot order of candidate names. Candidates are invited to attend and witness the drawing of the lots.

#### Withdrawal of Candidacy

Candidates wishing to withdraw their name must do so withing 96 hours of the close of nominations, i.e., by 12:00 noon on September 30, 2024.
