## 5. SELECTED TOPICS – GUEST PRESENTATIONS

The following guests made presentations to the Committee on the following topics:

Business License Requirements for 3 or fewer rental units - Tara Goodwin-Chief

- Short Term Rentals (STRs) are causing housing shortage
- Owners of rentals are businesses and should require business licenses
- Business license bylaw loop hole exempts rental owners with three or fewer units

- Enforcement landlords should be held accountable
- Solutions close loop hole, make Building File Information more readily available, submit violations to Rental Tenancy Office (RTO)
- RTO/Landlord Act Overlaps should umbrella
- More data needed.
- Concern that units may not be in compliance with Fire and safety requirements and that tenants are fearful of reporting.

Kristina Craig, Yukon Anti-Poverty Coalition - Short Term Rentals, PIT Count

- Shared information about homelessness, living wage update and impact of STRs
- PIT count shows steady increase (197 in April 2023 compared to 151 in 2021) but is estimated to be 3x underestimate. Other state estimate 247 active homeless people.
- Barriers: rent, discrimination, substance abuse
- Need more affordable rental stock
- Financialization of rental stock and rise of STRs
- City regulations required, some ideas explored
- More data required
- Right stock of housing still short
